General Information

1. Each space measures 15' x 15'. Assignments will be made by the Boda Getta BBQ committee.
2. Food vendors must provide all materials for the booth space, including tables, chairs, equipment, tents and signage. (Tents are strongly encouraged!)
3. No amplified sound is allowed. Generators must be approved by the Boda Getta BBQ planning committee.
4. Acceptance/Rejection letters will be mailed upon receipt of application. The Boda Getta BBQ planning committee has the right to deny an application if several other applications have already been accepted for the sale of similar goods.
5. No refunds will be made once an application is accepted, for any reason! Rejected applications will receive a full refund.
6. Please note vendor set-up may be delayed due to inclement weather conditions. If there is bad weather, you will be notified of any changes upon arrival to the park, or you may call (334) 887-7011. Boda Getta BBQ will not be rescheduled for another date. There will be NO REFUNDS.
7. Additional set-up information and times will be mailed to the vendor prior to the event. The vendor is responsible for all set-up. All food vendor applications are subject to approval by the Lee County Health Department. A Lee County Health Department Permit will be issued once your application has been reviewed and accepted. A photograph of your product and sample menu, must accompany this form or your application will not be accepted. For more information, please contact the Lee County Health Department at (334) 745-5765.
8. A City of Auburn Business License will not be required to be a vendor at the Boda Getta BBQ. However, if your business does any transactions outside of the BBQ, a business license should be purchased. For your convenience, sales tax forms will be provided in your confirmation packet. For additional information, please contact City of Auburn Finance Department at (334) 501-7228.

Please take the time to ensure your booth meets these standards before you arrive the day of the BBQ:

- You will not have access to a sink, so please have a hand dip station with bleach for hand washing.
- Latex gloves **MUST** be worn while handling food.
- Long hair **MUST** be tied back if handling food.
- Please control insects around the food.
- Please have food temperatures at the highest possible temperature.
- No eating is allowed in the area where food is prepared.
- Drinks are permitted for booth employees, but only with straws & lids.
